City of Dexter, Missouri Public Hearing Notice

There will be a Public Hearing held by the Dexter Board of Aldermen at 5:30 PM, August 27th, 2024 at the Dexter Municipal Building, 119 Vine Street, Dexter, Missouri. This will be a Public Hearing at which citizens may be heard on the tentative property tax rates proposed to be set by the City of Dexter, a political subdivision. The tax rates shall be set to produce the revenues which the budget for fiscal year beginning July 1, 2024, shows to be required from the property tax. Each tax rate is determined by dividing the amount of revenue required by the current assessed valuation. The result is multiplied by 100 so the tax rate will be expressed in cents per \$100 valuation.
