CITY AUDITOR'S REPORT

C.P.A. Eddie Cato presented the financial report for January 2025. The report showed the city had nearly \$8.3 million in cash and investments. In January disbursements of \$1,248,040.55 exceeded disbursements of \$1,100,346.51 by \$147,694.04.

The January Sales Tax was \$157,657, Capital Improvement Tax and Park and Recreation Tax were \$87,374. He reported this was a month that will reflect a debit service payment for the current bond, and he made entries showing funds owing each for a better reflection of each fund. The receipts for the month included sales tax, use tax, grant income, insurance proceeds from the storm damage, debit service interest subsidy and sale of assets for the fire department. The disbursements for the month included capital expenditures and grant expenditures. Mayor Snider agreed that entries showing funds owing others is a good disclosure.

CITY ADMINISTRATOR'S REPORT

City Administrator David Wyman reported the following:

- Dexter baseball team will play at Busch Stadium on April 2, 2025
- A public meeting will be held for Safe Streets for All grant and implementing codes building, fire, etc. codes.
- Building & Zoning Inspector Gary Williams has been compiling information for building permit applications, nuisance building demos, and shed nuisances. There are still 81 trees that have limbs hanging from the storm damage. Several ten-day notices have been issued for various reasons.
- Spring Cleanup will be held in April.
- Last year the City deployed dumpsters to each ward for a two-week period for cleanup. It cost the City approximately \$9,000.00. He asked the Board if they were still interested in doing this cleanup again this year. After some discussion, Alderman Aslin made a motion to deploy the dumpsters for a one-week period and have pickup each day, seconded by Alderman Tennison. Motion Carried unanimously.
